Here I provide bibliographic information for all the other texts he used. They are also footnoted in the individual lectures.

Given its contents, I have decided to use this as an initial basis for a bibliography of books he references in his lectures on the Origin and History of the Bible. He did not give complete bibliographic information, which I have supplemented here in blue. I also have rearranged the order of the books to be alphabetical by author.
